Petition For Small Estate Limited Letter Of Authority

Decedent must have lived in Sumner County for a minimum of six months.

Total Estate Value must be under \$50,000.00 (Excludes Real Property). If there is ANY real property to be transferred out of the decedent's name, YOU ARE NOT ALLOWED to file a small estate. (land, house and/or condo)

Original Will <u>must</u> be filed with the petition. The Will is <u>NOT</u> being probated. It <u>must</u> be filed into Court to support the petition. A copy of the death certificate <u>must</u> also be filed with the petition.

There is a 45-day waiting period from the date of death for a small estate to be heard before the Court. You may request for the waiting period to be waived for good cause. Please submit a typed or handwritten letter outlining the specific needs/reasons for the 45-days to be waived. The Clerk & Master will determine if the waiting period will be waived after reviewing request.

All heirs <u>must</u> be listed on the petition. Complete mailing addresses must be included. A competent adult that is not an heir may be allowed to serve as the Personal Representative, if all heirs have given their consent in writing. Consents <u>must</u> be filed into Court before petition can be heard.

Limited Letters of Administration / Testamentary <u>must</u> be signed by the Personal Representative and filed with petition.

Filing fee is \$150.50 – No personal checks are accepted. Please pay with cash, money order, cashier's check, or business check, made payable to Sumner County Chancery Court. Credit/Debit cards are accepted (A fee of \$3 or 3% whichever is greater will be assessed when using a card). Sumner County Government does not benefit from this fee.

If Personal Representative(s) lives out of state, a Nonresident Fiduciary must be filed with the State of Tennessee. The Nonresident Certificate issued by the State of Tennessee <u>must</u> be filed into Court before the small estate can be heard. A copy of the application is available upon request.
